- 31 Best, Richard Irvine. *Bibliography of Irish philology and manuscript literature; publications 1913-1941*. Dublin: 1942. 253 p.
Contains publications on philological topics of lexicography, grammar, metrics, inscriptions, glosses, and manuscripts; and also on literary topics of tales, sagas, poetry, religion, history, law, and others. A continuation of that published in 1913 for the Rational Library of Ireland.
- 32 Brian Keogh (Bookseller). *Catalogue two*. Buckinghamshire, Eng.: 1974. 132 p.
- 33 - *Catalogue three*. Buckinghamshire, Eng.: 1975. 167 p.
Books offered for sale in these catalogs are all related to Ireland either by author or content. A brief description of books which are particularly rare or interesting is included.
- 34 *A catalogue of the Bradshaw collection of Irish books in the University Library Cambridge*. Cambridge: 1916. 3 v.
The books in this catalog are those Irish books inherited by Henry Bradshaw from his father and presented to the University Library in 180; a second collection made by him between 180 and 1886; and books added by purchase or gift. They consist of books printed in Ireland, written by Irishmen, or relating to Ireland. Thousands of items (volumes, pamphlets, newspapers, etc.) are included.
- 35 Deutsch, Richard R. *Northern Ireland, 1921-1924: A select bibliography*. New York: 1975.
Covers the period from the Anglo-Irish Treaty of 1921 to the 197 riots and protests. Includes pamphlets, newspapers, background information, and both fiction (novels, plays, poetry and song) and non-fiction works.
- 36 Dix, Ernest Reginald McClintock, comp. *Catalogue of early Dublinprinted books, 1601 to 1700. With an historical introduction and bibliographical notes by C. Winston Dugan*. New York: 1971. 4 v. in 2 (386 p.)
A list of books printed in Dublin in the 17th century. This was a time of civil war and instability in Ireland, and many authors published on the Continent, then smuggled books into Ireland. Anti-Catholic laws also account for the dearth of Irishprinted books. Biographical and historical notes are included.
- 37 Eager, Alan R. *A guide to Irish bibliographical material, being a bibliography of Irish bibliographies and some sources of information*. London: 1964. xiii, 392 p.
A quick reference guide for those interested in Irish studies and research work. Includes author and subject index.
- 38 Fulton, John Farquhar. *A bibliography of the Honourable Robert Boyle, fellow of the Royal Society*. 2d ed. Oxford: 1961. xxxvi, 217 p.
The writings of Robert Boyle give a cross-section of scientific, philosophical, and religious thought in the late 17th century. Includes separate works, contributions to other works, collected works, and biography and criticism. Appendices list Boyle's lecture sermons (series of lectures in defense of natural and revealed religion provided for in Boyle's will), and the Robert Boyle lectures at Oxford University.
- 39 Hanson, Laurence William. *Contemporary printed sources for British and Irish economic history, 1701-1750*. Cambridge: 1963. xxiii, 978 p.
"Every new English work on economic affairs in the period," 1701-1750. Does not include translations, public acts, estate acts or bills, or newspapers. Divided into categories of

general, agriculture, manufactures, commerce, colonies, finance, transport and social conditions.

40 Hodges, Figgis & co., Ltd., Dublin. *Celtic studies*. Dublin: 1968. 146 p.

A catalog from a bookseller's firm which may serve as a bibliography of Celtic studies, prepared by Pídraig Ó Tuairín an authority on Celtic books. Descriptions of particularly rare or interesting volumes included.

41 Hughes, Kathleen. *Early Christian Ireland: introduction to the sources*. Ithaca, N.Y., 1972. 320 p.

Bibliography: p. 302-315.

Introduces the various kinds of source material for the study of early Christian Ireland, the problems presented by each, and the sort of questions it will answer. Includes a detailed chapter on the annals, but does not cover the linguistic aspect of the subject.

42 Kenney, James Francis. *The sources for the early history of Ireland; an introduction and guide*. Vol. 1: *Ecclesiastical*. New York: 1929. xvi, 807 p.

Covering primarily the period prior to the Anglo-Norman invasion (to A.D. 1170), this volume deals with "Sources that have a character or associations predominantly ecclesiastical, and also with the references to Ireland that are found in the ancient writers of continental Europe and of Britain." The general form used gives title, date or approximate date, the *incipit* and *explicit* of the text, a bibliographical paragraph (listing mss. and editions and the major commentaries in books and periodicals), and a summary of document's character and significance along with the results of critical study.
